National Park Service

Publishes Technical Report on Archeological Site Stabilization Information Sources

National Park Service (NPS) Director James M. Ridenour has announced the issuance of the report *Site Stabilization Information Sources*. The report, also called Technical Brief No. 12, is the latest in a series of technical information reports that the NPS Archeological Assistance Division publishes.

Archaeologists and cultural managers currently responsible for the protection of archeological sites and the management of the cultural resources within these sites have to work within a legislative framework that favors minimal impact to the site and the resources.

Technical Brief No. 12 highlights the process of a stabilization project, which is a multi-discipline effort between the archeologist and/or he cultural resources manager in charge of the project and the stabilizaton specialists whose techniques may be needed.

Archeologists and/or cultural resources managers are encouraged to become familiar with the different site stabilization techniques. Sources of technical information from various government agencies and private organizations are described; contact addresses and telephone numbers are listed.

Eduators are an important audience, and the essays demonstrate how educators, by including archeology in their curricula, can successfully teach students about their past.
